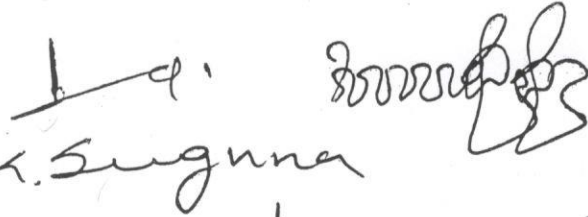
1. In the principle deed at page No.7 after clause 4(1) Delete sub clause (c) and (g) as follow:

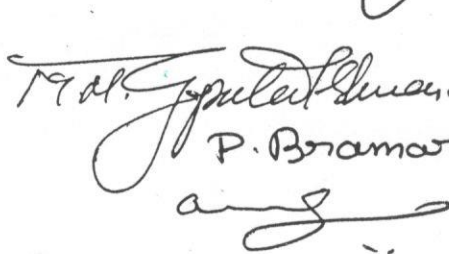
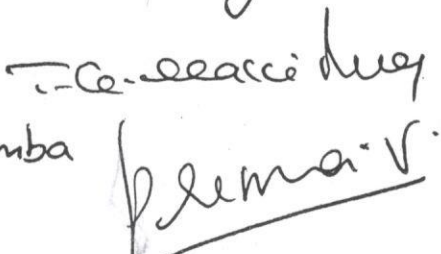

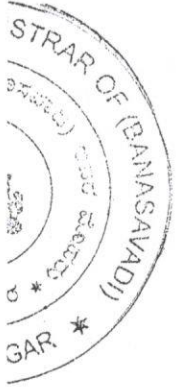
4. In the Principle deed at page 8, in clause 3, line 3 delete the words "the total number of Trustees in any event shall not exceed nine".

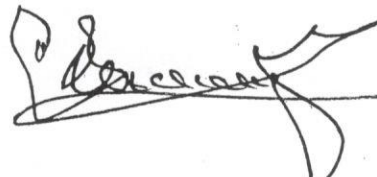
